I am concerned when I realize that the full pages of "We want to hear from you" in English and French newspapers are completely hiding the fact that the Yukon Party plans to amend the Oil and Gas Act without consulting Yukoners as it said it would do last spring. Instead, the Yukon Party government plans to rely on "consultation" from 2009.

I must remind the government that:

In 2009, "fracking" was not known to Yukoners.

There was no "French" consultation on this important subject, as is required under Yukon law

Today, my understanding is that, even with these amendments, there is no protection from the controversial subject of hydraulic fracturing, also called "fracking" or unconventional drilling.

I am pleased that Mr. Jim Tredger from the NDP has put forward a motion (No. 275) asking for a moratorium on hydraulic fracturing.

This motion will be discussed on Wednesday, Nov. 21 at the legislative assembly, and you will have to make a very important decision on this motion.

Last week, I heard Energy, Mines and Resources Minister Brad Cathers say: "They may or may not use hydraulic fracturing." The public and the cabinet should be aware that there is much psychological finesse surrounding this subject.

It is why the oil industry has hired the same company, Hill and Knowlton, which was announcing that cigarettes were good for us years ago.

Now, we can hear them on TV and everywhere saying that "Natural gas is safe and is our future." Natural gas is obtained by hydraulic fracturing.
